ADDENDUM TO PENSKE TRUCK RENTAL AGREEMENT FOR NATIONAL RENTAL ACCOUNTS

This Addendum to the Penske Truck Rental Agreement (“Addendum”) supplements, modifies and is incorporated into the Truck Rental Agreement between Penske Truck Leasing Co. L.P. and Teen Challenge USA (“Company”). In the event of any conflicts between the terms of the Agreement and this Addendum, the terms of this Addendum shall control. For good and valuable consideration, the sufficiency of which is acknowledged, the parties agree as follows:

A. Pricing. Company shall be entitled to the attached discounted rates (“Discounts”), through participating Penske locations and agents. Discounts are subject to review and adjustment by Penske. The Company will pay all Penske invoices under this program within thirty (30) days of the invoice date.

Penske reserves the right, based on market conditions, to review and adjust pricing provided they notify customer in writing thirty (30) days prior to an increase date. For the avoidance of doubt, any such increase will be effective thirty (30) days from written notice to customer and applicable to all equipment currently on rent as well as rental reservations on or after the effective date of increase.

Discounts are not available for charges in connection with any additional, extra or substitute vehicle under a Vehicle Lease Service Agreement or Vehicle Maintenance Agreement and any charges or amounts therefor.

B. Discount. Company employees shall be entitled to at-the-counter discount of ten percent (10%) for personal truck rentals (excluding rentals of refrigerated vehicles and tractor and trailer rentals) upon the employee's presentment of appropriate Company identification.

This Addendum shall become effective as the last execution date set forth below and shall remain in effect until terminated by the party’s upon (30) days' prior written notice.
